Results of Operations

For the period ended June 30, 2025, the Fund had total returns of 4.1% (Series A), 4.6% (Series F2), and 4.6% (Series F), and 4.3% (Series D).

The Canadian bond market, as represented by the FTSE Canada Universe Bond Index, returned 1.4% for the 6-month period ending June 30, 2025. The 10-year Government of Canada yield began the year at approximately 3.2%, dipped to a low near 2.8% in March, and ended the period at 3.3%. The Bank of Canada (BoC) cut rates twice – 25 bps in January and another 25 bps in March – bringing the overnight rate to 2.75% by mid-year, as inflation continued to ease and growth remained subdued. Credit spreads, as measured by ICE BofA Canadian corporate indices OAS (Option-Adjusted Spread) widened in February amid geopolitical tensions and slowing global growth. Credit spreads saw additional pressure in Q2 due to renewed tariff announcements by the Trump administration, which raised concerns about corporate margins and global trade flows. However, spreads gradually narrowed into June as markets adjusted to the policy environment and risk appetite returned, particularly in investment grade.

In the U.S., the 10-year Treasury yield fell from around 4.6% at the start of the year to 4.3% by the end of June. Despite market expectations for further easing, the Federal Reserve held the federal funds rate steady throughout the first half of 2025, following a series of cuts in late 2024. The Fed's cautious stance reflected persistent inflation pressures and uncertainty surrounding the economic impact of new trade policies.

The Canadian equity market ended the 6-month period in positive territory as the S&P/TSX Composite Index returned 10.2%. The Canadian economy demonstrated resilience amid global uncertainty, supporting a strong performance in domestic equity markets. The S&P/TSX Composite Index rose meaningfully, buoyed by improving macroeconomic fundamentals and a favorable monetary policy environment.

Global equities advanced over the 6-month period as the MSCI World Index (C\$) returned 4.1%. The first half of 2025 witnessed equity markets seesaw from negative to positive territory. The volatility was a result of President Trump's tariff threats, weaker consumer spending and turmoil in the Middle East.

Canada's GDP growth remained modest but positive, underpinned by steady consumer spending and a resilient labour market. Inflation continued to ease, with headline CPI falling to around 2.3% by March, down from earlier highs, thanks to declining energy and travel costs. This moderation in inflation allowed the Bank of Canada to continue its rate-cutting cycle, lowering its policy rate by 25 basis points in both January and March, contributing to improved borrowing conditions and investor sentiment. Despite global trade tensions and the imposition of new U.S. tariffs, Canadian exports held up relatively well, supported by strong demand for commodities like copper and gold. The materials sector, particularly mining, led equity gains, reflecting global supply concerns and rising prices.

However, signs of economic softening emerged late in Q2, with job growth slowing and business investment showing caution. Still, the overall economic backdrop remained supportive of equities, with no immediate signs of recession or aggressive monetary tightening. In summary, the first half of 2025 was marked by a "soft landing" scenario: inflation cooled, interest rates declined, and economic growth persisted at a moderate pace. These conditions created a favorable environment for Canadian equities, particularly in cyclical and resource-driven sectors.

In Canada, ten of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 6-month period. The best performing sectors were Materials, Consumer Discretionary and Financials. The only negative performing sector was Health Care. For global equities, seven of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 6-month period, with Industrials, Financials and Utilities being the

largest contributors to index returns. The worst performing sectors were Real Estate, Consumer Discretionary and Health Care.

Over the period, the Canadian dollar strengthened against U.S. dollar, weakened against the Euro currency, British pound and Japanese yen.

The Fund's exposure to liquid alternatives continued to provide risk diversity, as well as positive performance to the Fund. Both the equity oriented MD Strategic Opportunities Fund, Series I, and the alternative fixed income exposure held within the MD Strategic Yield Fund, Series I, had a positive return during the period.

The Fund's active multi-strategy structure combines complementary investment approaches. The Fund is actively managed, with positions altered based on relative opportunities. At the end of June, the Fund held an overweight tactical exposure to equities with a corresponding underweight to fixed income.

As at June 30, 2025, the total net asset value of the Fund was \$793.21 million, an increase of 2% since the beginning of the year. The increase is due to net investment gain, offset by net redemptions.

Recent Developments

STRATEGIC CHANGES

There have been no strategic changes and the Fund continues to be managed in a manner consistent with its investment mandate and is positioned to achieve its long-term objectives. The Investment Advisers have adhered to their investment disciplines and portfolio strategies.

Related Party Transactions

MD Financial Management Inc. is the Manager, Registrar and Trustee of the Fund. As Manager, MD Financial Management Inc. manages the overall business of the MD Family of Funds and the MDPIM Pools (collectively "the Funds") and is responsible for: setting investment objectives, providing and/or retaining the services of third party service providers for fund accounting services, administration services, and promoting the sales of the Fund's units.

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia (Scotiabank).

1832 Asset Management LP, a subsidiary of Scotiabank, is the portfolio manager of the Funds. MD Financial Management Inc., as Manager, continues to have overall responsibility for the management of the Funds. MD Financial Management Inc. is the registered portfolio manager and provides the discretionary portfolio management services to managed-account clients through MD Private Investment Counsel. 1832 Asset Management LP is responsible for the overall performance of the Funds, the management of fund assets and the selection and monitoring of the Funds' sub-advisors.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

As Registrar, MD Financial Management Inc. keeps track of the owners of units of the Fund, processes purchase, transfer and redemptions orders, issues investor account statements and issues annual tax reporting information.

As the Fund is organized as a Trust, investing in the Fund means purchasing units of the Trust. As Trustee to the Fund, MD Financial Management Inc. holds actual title to the property in the Fund – the cash and securities the Fund invests in – on behalf of the unitholders.

The principal distributor is MD Management Limited. As principal distributor, MD Management Limited markets the units of the Fund through its offices across

Canada. MD Management Limited is a wholly owned subsidiary of MD Financial Management Inc.

INDEPENDENT REVIEW COMMITTEE

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI81-107.

The IRC may also approve certain mergers between the Fund and other funds and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members: Stephen J. Griggs (Chair), Heather A.T. Hunter, Cecilia Mo and Steven Donald each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders, as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The compensation for the IRC is an annual flat fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager is required to advise the IRC of any breach of a condition of any standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager’s written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of its management of the Fund relied on IRC standing instructions regarding related party transactions as set out below:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Purchases of securities of a related party;
- Investment Advisor Monitoring and Oversight

Management Fees

MD Financial Management Inc. provides the Fund with investment management and administrative services, including fund accounting and unitholder record-keeping. In return, MD Financial Management Inc. receives an annual management fee and an annual administration fee, both based on a fixed percentage of the daily net asset value of the Fund. Management fees are paid weekly and administration fees are paid monthly.

MD Financial Management Inc. pays MD Management Limited, a related party, a fee for providing financial planning services to Series A unitholders. The estimated breakdown of the services received in consideration of the management fee for Series A is as follows:

Series F and F2 unitholders pay a separate managed account fee directly to MD Management Limited. 100% of the management fee on Series F, Series F2 and Series D is for investment management and other services.

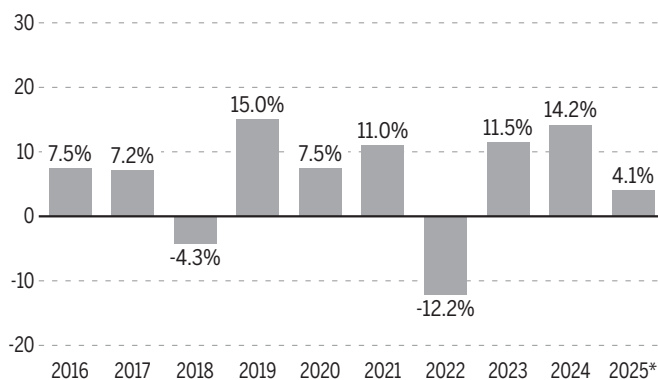
Past Performance

Series A

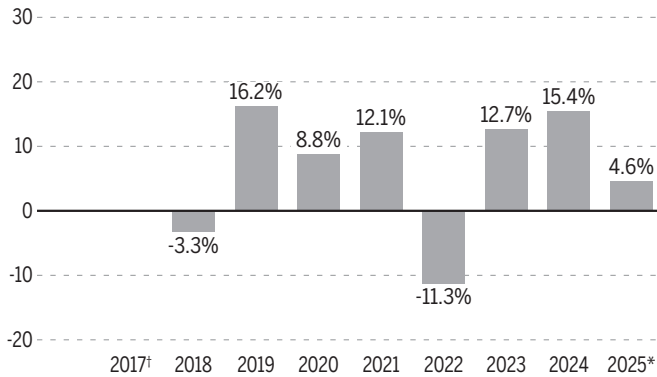

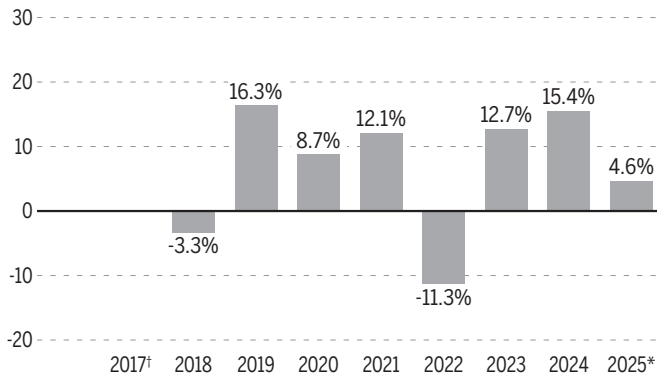

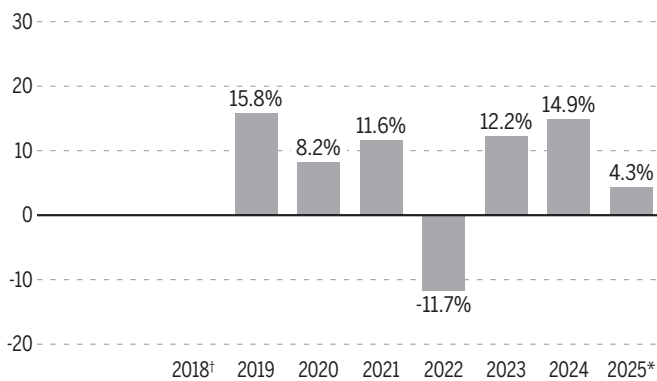
