### Results of Operations

For the period ended June 30, 2025, the Fund had total returns of 0.4% (Series PT), -0.3% (Series A).

The U.S. equity market ended the 6-month period relatively flat as the S&P 500 Index (C\$) returned 0.8%. The first half of 2025 witnessed equity markets seesaw from negative to positive territory. The volatility was a result President Trump's tariff threats, weaker consumer spending and turmoil in the Middle East.

President Trump's initial proposal of tariffs sent shockwaves to both equity and bond markets. The signal from the markets was this would send inflation and interest rates up, weaken consumer and business confidence and trigger a recession. Though, President Trump did dial back the tariffs from his initial proposal, tariffs did go into effect on Canada, Mexico and China, as well as on autos, steel and aluminum. This did have an impact on economic growth as the U.S. economy contracted at an annualized rate of 0.5%. This was largely driven by anemic growth in consumer spending and exports.

On the monetary side, U.S. Federal Reserve (Fed) Chair Jerome Powell acknowledged there has been little evidence of tariffs pushing up inflation. Some Fed officials have said a rate cut could be on the table in their next meeting depending on what the economic data looks like. The last Fed rate cut occurred in December 2024.

Seven of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 6-month period. The best performing sectors were Industrials, Communication Services and Utilities. The worst performing sectors were Consumer Discretionary, Health Care and Energy.

Over the period, the U.S. dollar weakened against most major currencies including the Canadian dollar, Euro currency, British pound and Japanese yen.

Out of the eleven sectors represented in the Fund, the IT, Financials and Consumer Discretionary sectors received on average the highest portfolio weightings, while the Real Estate, Utilities and Energy sectors received the lowest allocation. The majority of sectors contributed positively to performance, with the most robust contributions coming from the IT, Financials and Industrials sectors.

The Fund's active multi-strategy structure combines complementary investment approaches. The Fund is actively managed, with positions altered based on relative opportunities.

As at June 30, 2025, the total net asset value of the Fund was \$4.28 billion, a decrease of 1% since the beginning of the year. The decrease is due to net redemptions and income distributions to unitholders, offset by net investment gain.

### Recent Developments

#### STRATEGIC CHANGES

On March 11, 2025, MD Financial Management Inc. (MD) announced the appointment of Pzena Investment Management as an investment sub-advisor for the MDPIM US Equity Pool. The revised investment sub-adviser structure for the Fund will have Pzena join Fiduciary Management Inc., Jensen Investment Management, Janus Henderson Investors US LLC and 1832 Asset Management L.P.. These changes will not alter the fund's investment objectives or investment risk level.

There have been no strategic changes and the Fund continues to be managed in a manner consistent with its investment mandate and is positioned to achieve its long-term objectives. The Investment Advisers have adhered to their investment disciplines and portfolio strategies.

### Related Party Transactions

MD Financial Management Inc. is the Manager, Registrar and Trustee of the Fund. As Manager, MD Financial Management Inc. manages the overall business of the MD Family of Funds and the MDPIM Pools (collectively "the Funds") and is responsible for: setting investment objectives, providing and/or retaining the services of third party service providers for fund accounting services, administration services, and promoting the sales of the Fund's units.

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia (Scotiabank).

1832 Asset Management LP, a subsidiary of Scotiabank, is the portfolio manager of the Funds. MD Financial Management Inc., as Manager, continues to have overall responsibility for the management of the Funds. MD Financial Management Inc. is the registered portfolio manager and provides the discretionary portfolio management services to managed-account clients through MD Private Investment Counsel. 1832 Asset Management LP is responsible for the overall performance of the Funds, the management of fund assets and the selection and monitoring of the Funds' sub-advisors.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

As Registrar, MD Financial Management Inc. keeps track of the owners of units of the MDPIM Pools, processes purchase, transfer and redemption orders, issues investor account statements, and issues annual tax reporting information.

As the Fund is organized as a Trust, investing in the Fund means purchasing units of the Trust. As Trustee to the Fund, MD Financial Management Inc. holds actual title to the property in the Fund – the cash and securities the Fund invests in – on behalf of the unitholders.

Units of the MDPIM Pools are only available to clients of MD Private Trust Company or discretionary managed account clients of MD Financial Management Inc. MD Management Limited ceased to be the principal distributor of the MDPIM Pools as effective October 29, 2018.

#### INDEPENDENT REVIEW COMMITTEE

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members: Stephen J. Griggs (Chair), Heather A.T. Hunter, Cecilia Mo and Steven Donald each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders, as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing

basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The compensation for the IRC is an annual flat fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager is required to advise the IRC of any breach of a condition of any standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of its management of the Fund relied on IRC standing instructions regarding related party transactions as set out below:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Purchases of securities of a related party;
- Investment Advisor Monitoring and Oversight

## Management Fees

MD Financial Management Inc. provides the Series A units of the Fund with investment management and administrative services, including fund accounting and unitholder record-keeping. In return, MD Financial Management Inc. receives an annual management fee and an annual administration fee, both based on a fixed percentage of the daily net asset value of the Fund. Management fees are paid weekly and administration fees are paid monthly.

No management fee is charged in respect of the PT Series of the Fund. Investors in the PT Series of units have agreed to pay a managed account fee directly to MD Financial Management Inc.

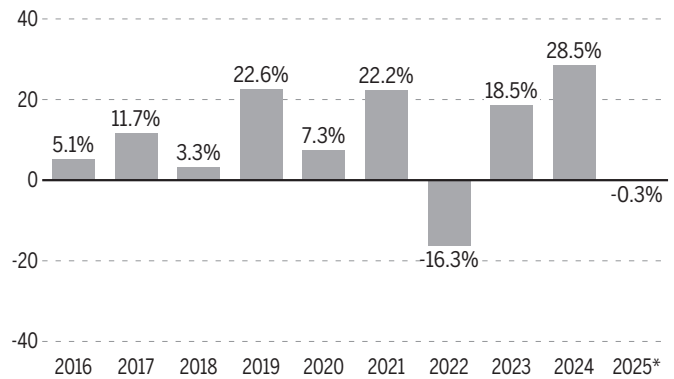
## Past Performance

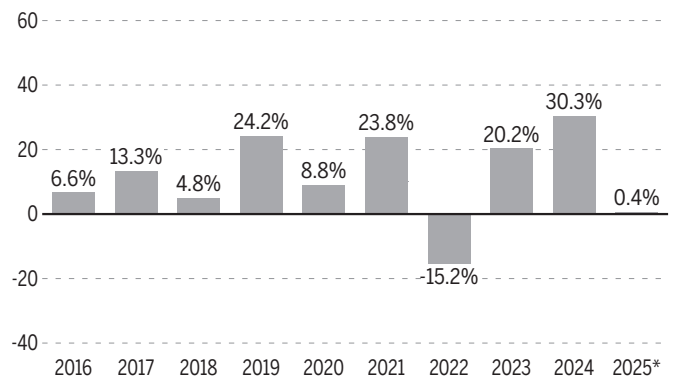
## YEAR-BY-YEAR RETURNS

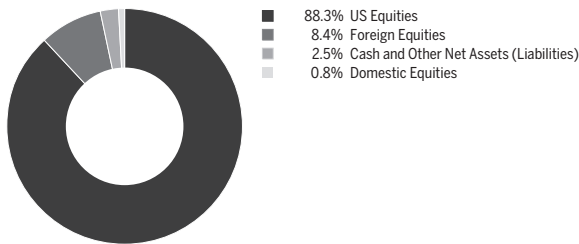

The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.
