On or about February 10, 2025, the index that the Fund tracks will be changed to another generally recognized broad based international equity market index, Solactive GBS Developed Markets ex. North America Large & Mid Cap Index. As a result, the Fund will make consequential changes to its investment objectives and strategies.

What does the Fund invest in?

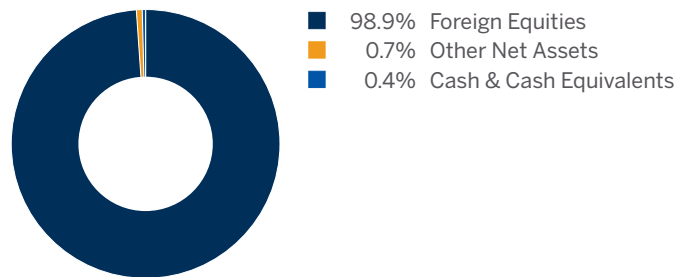
The Fund seeks to provide long-term growth of capital through investment in primarily international equity securities that generally track the holdings and performance of the MSCI EAFE Index.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk Rating

MD Financial Management Inc. has rated the volatility of this Fund as **medium**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

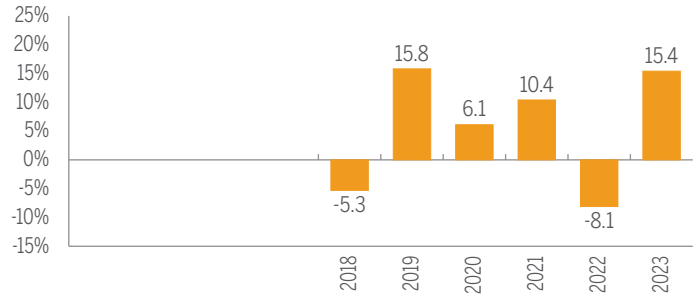
Like most mutual funds, this Fund does not have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how Series A units of the Fund have performed over the past 6 years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

This chart shows how Series A units of the Fund performed in each of the past 6 calendar years. The Fund dropped in value in 2 of the 6 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series A units of the Fund in a 3-month period over the past 6 years to September 30, 2024. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

As at September 30, 2024, a person who invested \$1,000 in Series A units of the Fund at its inception would now have \$1,610. This works out to an annual compound return of 6.8%.

Who is this Fund for?

Investors who:

- Are looking for a fund that is suitable as a core international investment within a well diversified portfolio.
- Are seeking a passive investment approach to investing in international stocks.
- Have an investment time horizon of over ten years.

This Fund is not suitable for an investor seeking a short-term investment or concerned about foreign investment risk.

A word about tax

In general, you'll have to pay income tax on any money you earn on a fund. How much you pay depends on the tax laws where you live, the type of earnings (i.e., income or capital gains), and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your Fund in a non-registered account, taxable fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series A units of the Fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

There are no sales charges applicable to this Fund.

2. Fund expenses

You do not pay these expenses directly. They affect you because they reduce the Fund's returns.

As of June 30, 2024, the Fund's expenses were 0.01% of its value. This equals \$0.10 for every \$1,000 invested.

More about trailing commissions

MD Financial Management Inc. does not pay any trailing commissions in respect of units of the Fund.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

FEE	WHAT YOU PAY
Managed account fee	Unitholders pay a scaled managed account fee based on assets under management. Maximum fee is 1.56%.
Early redemption fee	2% of the amount redeemed or switched if the redemption or switch occurs within thirty (30) days from the date the units were purchased or switched.
Transfer-out fee	\$135 plus applicable taxes for each registered or non-registered investment account transferred in whole or in part to another financial institution.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
