# MDPIM Emerging Markets Equity Pool

### Investment Objectives and Strategies

The MDPIM Emerging Markets Equity Pool (the "Fund") seeks to achieve long-term growth of capital by investing in a diversified portfolio of primarily emerging market equity securities.

The Fund employs a multi-manager approach which seeks to deliver excess returns compared to the benchmark and to provide diversification by avoiding overconcentration in any single style, sector or market trend. Fund assets are allocated to a combination of the investment advisers for the Fund, based on the Manager's assessment of the investment advisers' skills, the predicted capital market environment, and the anticipated risk inherent in each investment adviser's strategy.

The Fund may not invest in companies that manufacture tobacco or tobacco-related products or cannabis or cannabis related products.

### Risk

At times, a portfolio can be subject to any number of investment risks. The risk level of the Fund did not change significantly during the year. Descriptions of the investment risks associated with this Fund are detailed in the Simplified Prospectus.

### Results of Operations

For the period ended December 31, 2023, the Fund had total returns of 12.8% (Series A), 13.3% (Series I), 11.8% (Series D), and 12.3% (Series F).

Emerging market equities participated in the rebound in global equity markets with the the MSCI Emerging Markets Index (C\$) having returned 7.3% over the past 12-month period. This return lagged gains in other markets like the US, Europe and Japan due primarily to weakness in Chinese equity markets.

China continues to suffer from continued weakness in the housing sector and its knock on effects to the rest of the economy which have led to reduced confidence and deleveraging. This has led to deflation with Chinese CPI falling on a year on year basis for much of Calendar 2023. In this weak environment, Chinese equities fell over 13% in Canadian dollar terms over the 12-month period and started the year with a weight of more than 30% of the benchmark, making it a significant detractor to the aggregate emerging market benchmark return over the 12-month period. However, outside China, there were significant gains in most other emerging markets. Eastern Europe and Latin American saw particular strength with Poland, Hungary, Mexico and Brazil all up 30% or more in Canadian dollar terms. Taiwan, Korea and India which are the largest countries after China in the index were also up between 18% to 27%.

The Fund's regional allocations were mostly focused in East Asia, China, Taiwan and Korea, which represent approximately half of the fund on average over the period. The next largest market allocations are to India, Brazil and Mexico which combined over 20% on average for the 12-month period. The remaining country allocations in the Fund are split across the remaining emerging markets as well as select multi-nationals that derive a significant part of their revenue from emerging markets. In terms of contribution to return, Taiwan, India, Korea and Brazil were the strongest positive contributors to return as these markets were quite strong with significant weights, while China was by far the biggest detractor for the reasons noted earlier. The only other country to make a material negative contribution to return was South Africa due to weakness in some materials sector companies held. However, the negative impact to return of South Africa at the portfolio level was modest, at less than 1%.

Seven of the 11 sectors represented in the portfolio contributed positively to the Fund's return in Canadian dollar terms. Information Technology, Financials and Industrials were the three biggest positive contributors to return due to their large weight and strong returns. In contrast, the Materials, Communication Services and Real Estate sectors were the only three sectors to have a material negative contribution to return for the period.

The Fund's active multi-manager structure combines complementary investment approaches. Over the period one new advisor was added to the Pool, however, the overall sector and regional positions did not materially change as a result. As a result of active management and market movements, the weight of China declined and the weight of India increased modestly. There were also modest decreases in Communication Services and Energy and an increase in Information Technology. All the country and sector shifts noted were less than 5% at the portfolio level.

As at December 31, 2023, the total net asset value of the Fund was \$1.92 billion, an increase of 10% since the beginning of the year. The increase is due to net investment gain and net contributions offset by income distributions to unitholders.

### Recent Developments

#### STRATEGIC CHANGES

On March 10, 2023, MD Financial Management Inc. (MD) announced the appointment of Pzena Investment Management as an investment sub-adviser for the MDPIM Emerging Markets Equity Pool. The revised investment sub-adviser structure for the Fund will have Pzena join Grantham, Mayo, Van Otterloo & Co. LLC (GMO) and Axiom Investors. These changes will not alter the fund's investment objectives or investment risk level.

There have been no strategic changes and the Fund continues to be managed in a manner consistent with its investment mandate and is positioned to achieve its long-term objectives. The Investment Advisers have adhered to their investment disciplines and portfolio strategies.

### Related Party Transactions

MD Financial Management Inc. is the Manager, Registrar and Trustee of the Fund. As Manager, MD Financial Management Inc. manages the overall business of the MD Family of Funds and the MDPIM Pools (collectively "the Funds") and is responsible for: setting investment objectives, providing and/or retaining the services of third party service providers for fund accounting services, administration services, and promoting the sales of the Fund's units.

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia (Scotiabank).

1832 Asset Management LP, a subsidiary of Scotiabank, is the portfolio manager of the Funds. MD Financial Management Inc., as Manager, continues to have overall responsibility for the management of the Funds. MD Financial Management Inc. is the registered portfolio manager and provides the discretionary portfolio management services to managed-account clients through MD Private Investment Counsel. 1832 Asset Management LP is responsible for the overall performance of the Funds, the management of fund assets and the selection and monitoring of the Funds' sub-advisors.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

As Registrar, MD Financial Management Inc. keeps track of the owners of units of the MDPIM Pools, processes purchase, transfer and redemption orders, issues investor account statements, and issues annual tax reporting information.

As the Fund is organized as a Trust, investing in the Fund means purchasing units of the Trust. As Trustee to the Fund, MD Financial Management Inc. holds actual title to the property in the Fund—the cash and securities the Fund invests in—on behalf of the unitholders.

Units of the MDPIM Pools are only available to clients of MD Private Trust Company or discretionary managed account clients of MD Financial Management Inc. MD Management Limited ceased to be the principal distributor of the MDPIM Pools as effective October 29, 2018, except for Series I, Series F and Series D units of this Pool are available through accounts held at MD Management Limited, which acts as principal distributor in respect of those units. MD Management Limited is a wholly owned subsidiary of MD Financial Management Inc.

### INDEPENDENT REVIEW COMMITTEE

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members: Stephen J. Griggs (Chair), Heather A.T. Hunter, Jennifer L. Witterick and Steven Donald each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders, as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The compensation for the IRC is an annual flat fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager is required to advise the IRC of any breach of a condition of any standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of its management of the Fund relied on IRC standing instructions regarding related party transactions as set out below:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on a principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Purchases of securities of a related party;
- Investment Advisor Monitoring and Oversight

### Management Fees

MD Financial Management Inc. provides the Fund with management and administrative services. No management fee is charged in respect of units of the Fund. Investors in these units have agreed to pay a managed account fee directly to MD Financial Management Inc.

### Past Performance

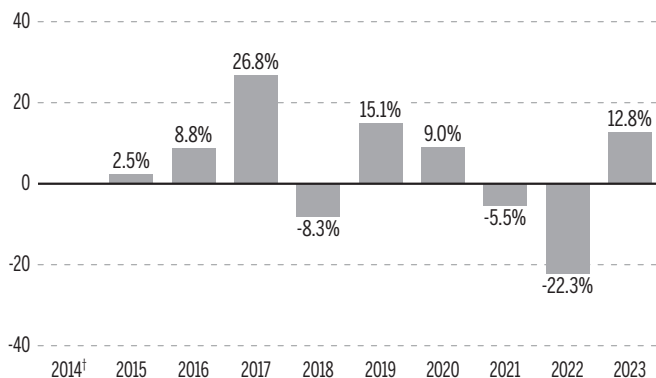

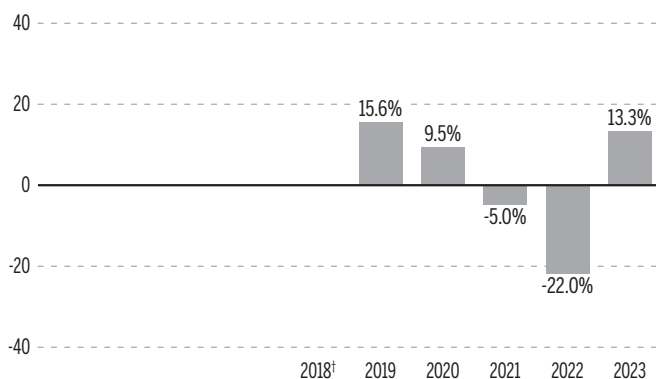
### YEAR-BY-YEAR RETURNS

#### Series A



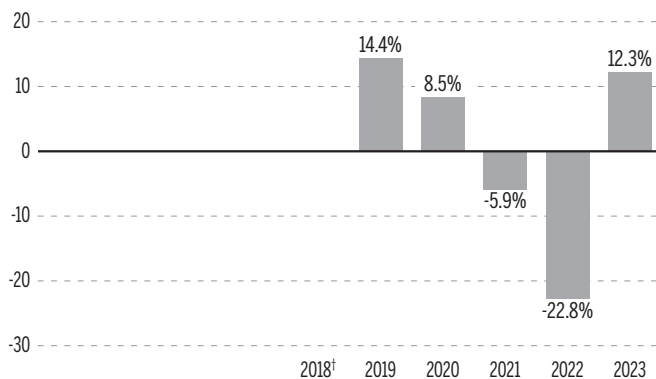

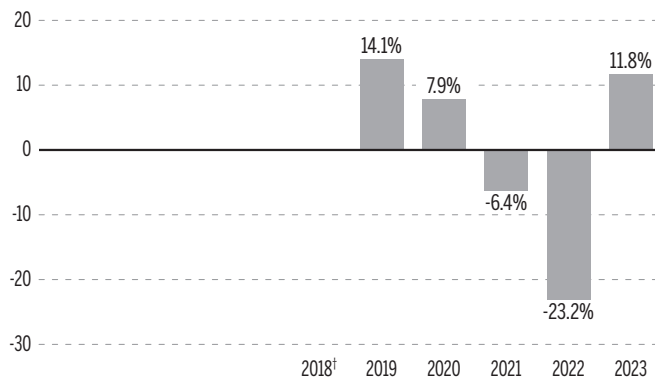

Management uses the MSCI Emerging Markets Index as the benchmark for this Fund because it represents the aggregate returns of securities listed on exchanges in emerging markets as defined by MSCI. Although index returns are hypothetical—as they do not reflect the true cost of owning or managing the underlying stocks—they are one of several useful indicators. By comparing the Fund's performance to the movements of the benchmark, we are able to assess how the Fund is doing. For example, some short-term deviations can signal the need for change while others confirm the expectations of a longer-term strategy. If management were to ascertain that a fund's over- or underperformance was the result of excessive risk-taking or deviation from the investment mandate, we would, on behalf of all our unitholders, address these issues with the Investment Adviser and make changes if necessary.

The Fund outperformed over the most recent one-year period. The strong relative performance over the past year was due to many factors: Strong stock selection in India, Taiwan and Korea as well as a significant underweight to China and an allocation to strong performing multinationals that derive a significant portion of their revenues from emerging markets. Over the three-, five-year and since inception periods the fund is behind the benchmark primarily due to an overweight to Russia prior to the war in Ukraine in 2022. These positions were written down to zero as they became untradeable following the invasion of Ukraine by Russia.

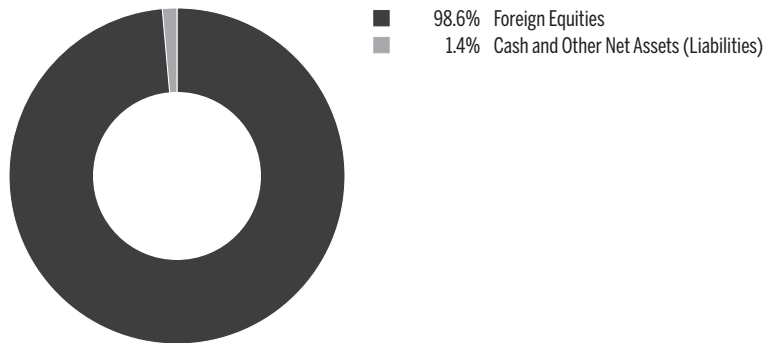
